

M7 TUNING – M7 SPEED
LIMITED LIFETIME WARRANTY AND REPLACEMENT POLICY
M7 EXTREME TEGRIS SPLITTER

M7 Tuning/M7 Speed (the warrantor) hereby warrants The M7 Extreme Tegriss Splitter (the product) to the original purchaser thereof (the consumer) against breakage under the following terms and conditions:

The Limited Lifetime Warranty is specifically limited to the original purchaser of the products and is enforceable only by such original purchaser. In the event of breakage of the splitter the Warrantor will replace the product, at the sole election of the Warrantor. This Limited Lifetime Warranty shall not apply to labor charges, freight, material or other incidental expenses in connection with removal and/or replacement of such damaged product on the Consumer's vehicle and does not cover installation hardware and other support parts and braces. The maximum liability of M7 Tuning/M7 Speed in connection with this warranty shall not under any circumstances exceed the current MSRP price of the product.

Breakage is defined as the splitter being in more pieces than its original configuration when purchased. Breakage caused by impact and crash damage is covered. The Limited Lifetime Warranty DOES NOT COVER gouges, dings, dents and abrasive wearing (dragging) of the splitter. All pieces must be returned to M7 when making a claim. Photographs of the car with the broken splitter still installed on the vehicle must be submitted with this warranty claim.

This warranty does not cover any product that has been subject to misuse, neglect, improper installation, modification or alteration. This warranty specifically excludes all labor and freight costs, chemical and UV damage.

All other warranty claims and replacements are defined in The M7 TUNING – M7 SPEED LIMITED WARRANTY AND REPLACEMENT POLICY.

M7 TUNING – M7 SPEED LIMITED WARRANTY AND REPLACEMENT POLICY

M7 Tuning/M7 Speed (the warrantor) hereby warrants its product to the original purchaser thereof (the consumer) against any and all defects in workmanship and material under the following terms and conditions:

The Limited Warranty is specifically limited to the original purchaser of the products and is enforceable only by such original purchaser. In the event of a defect in workmanship or material of the products, the Warrantor will repair or replace the product, or any defective part or parts thereof, at the election of the Warrantor, without charge to the consumer for such repair or replacement. This Limited Warranty shall not apply to labor charges, freight, material or other incidental expenses in connection with removal and/or replacement of such defective product on the Consumer's vehicle. This Limited Warranty shall extend for a period of ninety (90) days, commencing from the date of the original purchase by the Consumer. The only exception to this limited term is for M7 Tuning/M7 Speed Tegriss Splitters, which have a limited lifetime warranty (does not include ancillary components, labor, or freight).

The maximum liability of M7 Tuning/M7 Speed in connection with this warranty shall not under any circumstances exceed the purchase price only of the product claimed to be defective.

This warranty does not cover any product that has been subject to misuse, neglect, improper installation, alteration, modification, impact or accident. Normal wear shall not be considered a defect under this warranty. This warranty specifically excludes all labor and freight costs. This warranty specifically excludes impact damage, damage to powder-coated items and UV damage to carbon fiber parts.

M7 TUNING/M7 SPEED products are designed to be used with OEM product and other M7 TUNING/M7 SPEED products. M7 TUNING/M7 SPEED does not warranty our product for fitment with aftermarket product from other manufacturers. M7 TUNING/M7 SPEED products that are returned due to fitment issues with OEM components or M7 TUNING/M7 SPEED products will receive a full refund. M7 TUNING/M7 SPEED products that are returned due to fitment issues with aftermarket products, or for any other reason will be subject to a 25% restocking fee and freight costs.

The purchaser understands and recognizes that racing parts, aftermarket automotive parts, aftermarket automotive accessories and equipment manufactured by and/or sold by M7 TUNING/M7 SPEED, are subject to varied conditions due to the manner in which they are to be installed and used. The acceptability and suitability of any part sold or manufactured by M7 TUNING/M7 SPEED for a particular application is solely the purchaser's decision. M7 TUNING/M7 SPEED makes no warranties whatsoever, expressed or implied, or written, **THERE IS NO WARRANTY OF MERCHANTABILITY.** The right to make changes in the design or add to or improve on their product without incurring any obligation to install the same on products previously manufactured is expressly reserved. Buyer agrees to indemnify and hold Seller harmless from any claim, action or demand arising out of or incident to Buyer's installation or use of products purchased from M7 TUNING/M7 SPEED.

Products sold but not manufactured by M7 TUNING/M7 SPEED will carry the original manufacturer's warranty and that manufacturer will service the product directly according to the terms and conditions stated by the manufacturer.
